COMMENTS FROM THE CHAIR

The recent mass shootings in Las Vegas, NV, Parkland, FL and, closer to home, at CMU, continue to remind us of how dangerous our country is becoming. In today's America we are increasingly afraid to go to any outdoor or indoor activity where large numbers of people gather while many of our children are afraid to attend school. Today, in addition to children practicing fire drills, they also train for lockdown and active shooter situations. Yet we are told that the solution to all this is to arm everyone. Really! Will we really be safer with more guns on the streets?

Recently, I heard some statistics on TV that got me thinking a lot about gun control and safety. The reporter said that a recent survey found that only about 37% of Americans own a gun. He went on to say the only 3% of the 37% or just over 1% of our entire population, actually own more than 14 guns. This means that nearly two thirds of Americans don't even own a gun let alone possess an arsenal of weapons. Most gun owners own just a few guns that they use for hunting or personal protections in their homes! So why have we adults allowed a very small minority of our citizenry to dictate government policy?

On the bright side of this national disgrace, young people who attend the high school involved in this latest mass shooting, have declared that they have had enough of this tragic failure of our political system to respond to a clear need for reform. They know what it feels like to cower in fear while their classmates and teachers are callously murdered. Many of them have met with local, state and national officials and appeared on TV to demand change. They have held vigils, staged demonstrations and vowed to continue to challenge the adult community in this county to do what most of us know is the right thing. Personally, I have been deeply moved and inspired by these young people. I can only pray that their inspiring behavior moves enough concerned citizens to accomplish real and substantial reform so that we can all live in a safer community and country.

I urge all adults who feel as I do to find ways to support these inspiring young people, not just in Florida, but also right here in Manistee. There has been a call for demonstrations on this critical issue across the country on March 24th. If joining our demonstration and waiving a sign is not for you, then write some letters or call your representatives and let them know how you feel. Talk to friends and neighbors, and especially young people, about this issue. Contact local merchants who sell guns and urge them to stop selling assault weapons and the ammunition they use. In other words –“make some waves” – and pay close attention to the positions politicians take this year and hold them accountable when you vote. If enough of us do these things we will be heard.

WE GET THE GOVERNMENT WE PAY FOR

It's tax time, that time of year that we gratefully pay our fair share to our government. This is what pays for infrastructure, schools, public transportation, food stamps, health care subsidies and all the things that Democrats traditionally value.

THE NEW TAX LAW IS IN EFFECT

Unfortunately, most tax-payers won't know the effect this bill will have on them personally until after the midterm elections - and this is very deliberate. There are some details they aren't bragging about. You've heard the big deal about how they 'doubled' the standard deduction to simplify doing taxes. What isn't being talked about is that they have also "suspended" the personal exemption. The personal exemption is the \$4,050 credit you received for yourself, your spouse, plus each child or dependent that you support. Let's say you file jointly and have 4 children. This year, on top of the \$12,700 standard deduction, you get to deduct \$4,050 *per child plus you and your wife (a total of \$37,000)*. Next year it will be a \$24,000 standard deduction only. Zero for personal exemptions. That is a loss of \$13,000. If you are a single Mom with 4 children you will lose \$11,600. Taxes for these people will go UP. Promoters of the tax bill will tell you the child tax credit increased. It did, from \$1,000 per child to \$2,000 per child. Child tax credits are only on children under 17. That still leaves a big hole in your deductions and an increase in your taxes.

Last week I did a tax preparation for an 80 year-old woman who is still working to support her 46 y/o adult child who has borderline autism and can't hold a job. She's tried but can't get disability. The only deduction this senior citizen could get for supporting her daughter was a \$4,050 personal exemption. Next year she will get a \$500 dependency credit. She will also end up paying more taxes. Why aren't we hearing about these cases, instead of the teacher getting \$1.50 more in her weekly paycheck?

With this tax bill, it pays not to have a family. Also, with lower tax brackets at the upper income end, the more you make, the less you pay.

Northern Michigan Indivisible and Democratic Groups Present NRA-Supported Congressman Bergman with Check from 'The Spineless Foundation'

Bergman Refuses To Do Anything About Gun Violence Even After 17 People Were Killed in the Parkland, Fla. School Shooting Last Week

TRAVERSE CITY — On Tuesday, February 27th, five local Indivisible and Democratic groups from Benzie, Leelanau and Manistee Counties gathered at the Traverse City office of Congressman Jack Bergman (R-Watersmeet) and presented him with checks from “The Spineless Foundation” to commemorate his dedication to the National Rifle Association’s (NRA) dangerous agenda and refusal to do anything to solve gun violence. The check was made out to “Thoughts and Prayers” and was slid through the office “speakhole” if Congressman Bergman or his staff refused to meet with constituents.

Bergman, who represents the 1st Congressional District, tweeted condolences after the Marjory Stoneman Douglas High School shooting in Parkland, Fla. last week that killed 17 people, but the people of northern Michigan deserve action.

“Congressman Bergman has accepted thousands of dollars in campaign contributions from the NRA and other gun lobbyists and continues to do so for the 2018 election cycle. He voted to relax restrictions that help keep guns out of the hands of those with mental illness and to remove registration on silencers. Congressman Bergman consistently opposes gun safety measures that could save children’s lives. Who is that he is really representing?” said **Eric Lampinen**, member of the Manistee County Democrats.

- Gas stations receive an email at 6:00 pm every day giving the cost of a gallon of gas for the next 24 hours
- Profit from a gallon of gas: \$0.25 is great. Sometimes profits are as low as 2-3 cents/gallon
- Lower gas prices in big towns are the result of competition and volume of sales
- The Saddle Up receives one gasoline delivery a week during the winter, two deliveries in the summer. The cost for the delivery last week was \$32,000.00.
- One tank holds 25,000 gallons. The tank has three compartments: one for premium, one for diesel, and one for no lead
- Ethanol is full of “junk” and the pipes are deteriorating. The cost of “re-piping” will be \$50-\$60 thousand dollars
- New gas dispensers installed three years ago. Cost was \$85,000.00!!
- Many oil/ gas refineries in the US. Western Michigan terminals are located in Muskegon and Holland. Brenner Oil Co delivers Marathon products to the Saddle Up.
- The differences in the various brands are a result of the additives each brand adds to their gasoline
- Weather, politics, and gasoline prices are of interest to everyone. Lots of talk about each topic but not much, if anything, can be done about any of these issues, except BE SURE AND VOTE!!
- Candy and groceries including liquor are the backbone of profit for gas stations.
