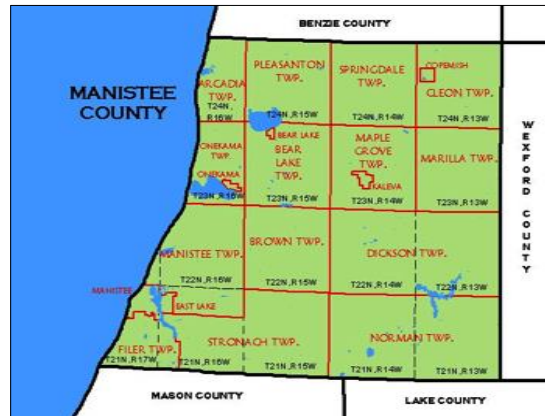
“VOTERS TAKE BACK POWER”

VOTERS NOT POLITICIANS

Last Thursday a bunch of ordinary citizens overturned decades of Republican gerrymandering by formally approving new maps for Michigan's Congressional, state House and state Senate districts. Now the party that gets the most votes will have a chance to get the most seats. The new voting districts create a fair opportunity in 2022 for the Democratic Party to take back control of the State Legislature.

The fairness, however, comes with the cost of splitting counties.

It will greatly increase the chance for Democrats to have a say in their State Legislature again.

We will no longer be running a candidate against Jack O'Malley for State Rep. Manistee County has been divided into 2 separate House districts (see above). We are also divided into two districts for the State Senate race too. Most of our county will be in District 32, with 4 Townships on the east side in District 36.

Michigan lost a Congressional seat and is now divided into 13 districts. Sadly, we are no longer in District 1 with a great candidate like Dr. Bob Lorinser to run against Jack Bergman. Manistee County is now in District 2 with counties to the south. Rep. John Moolenaar, a Trump Republican who also wanted to nullify the 2020 Michigan election results and support the insurrection, has declared he will run in our district.

Thanks to *Voters not Politicians* and citizens who worked hard to pass the citizen initiative (Prop 2) in 2018, Michigan is now one of 11 states that has an independent citizen panel that will redraw congressional and state district maps every 10 years after the census.

JOHN HELGE'S JANUARY NEWS COLUMN

We have recently been inundated with troubling images commemorating the first anniversary of the violent riot at the US Capitol that attempted to overthrow the results of the 2020 Presidential election. There are many among us who would like to just forget that this sort of insurrection could have ever happened in the United States of America, but we all have a responsibility as citizens to take on the work necessary to maintain our democracy. As citizens of this great country, it is our sacred responsibility to vote in every election to ensure our voices are heard and those we elect are held accountable for their actions as our representatives in national, state, and local governmental bodies. Once the ballots are counted and the results are announced the peaceful transfer of power has been one of the true differentiators of American democracy.

Many of us expect that the lies and misinformation spread by those seeking to overturn the free and fair 2020 election will not influence this long-standing process in the future. We need to continue to hold these elected officials and others in popular leadership positions accountable not only for their actions on January 6, 2021, but also for the fact that they have continued to create doubt in the validity and security of our election processes even after all the lawsuits, examinations, and audits proved otherwise. It is one thing for your neighbor to say they dispute the election results by citing some off-the-wall conspiracy theory—that's their right of free speech. But it is a serious breach of trust when the Big Lie is repeated by those whom we have elected to represent us in crafting meaningful legislation at the state and national level.

Voting should be an easy task for every US Citizen. We are truly fortunate here in Manistee County to have experienced and dedicated clerks and volunteer poll workers at the Township, City, and County levels who do the heavy lifting that makes it simple and easy for us to cast our votes on election day. These are the people who follow the rules and procedures to make sure every election is fair and free from fraud of any kind. We should never advocate taking those responsibilities away from these local experts and putting them in the hands of potentially biased legislators or bureaucrats in Lansing or Washington DC.

Placing legislative restrictions or limitations on the election process does not improve election integrity it simply makes it more difficult for some to vote. Recent moves by the Michigan and other state legislatures in 2021 are great examples of why it is so important to have Federal voting rights actions in place to protect the right of all US Citizens to vote.

Not every US Citizen is able or capable of physically getting to their assigned polling place on election day. Work schedules and health issues often get in the way of casting their vote.

- It would be a great idea to make the major November election day a national holiday so more could find the time to vote.
- No US Citizen should have to stand in line for more than 2 hours to cast their vote. Densely populated areas should have more polling sites, not fewer.
- Absentee ballot voting has been proven to be a safe and secure alternative that has increased voter participation in the democratic election process. Everyone should be able to take advantage of this easy opportunity to participate.
- Early in-person voting is also a good way to increase the ability of more citizens to have their voices heard.
- Allowing the clerks to process and count these early and absentee voting ballots would also improve the time required to provide accurate results once the polls officially close.

In Michigan we should also raise the alarm about the ability of a very small minority of citizens to bypass the legislative process by getting 340,000 signatures on a petition. This number represents less than 3.5% of the

9,987,000 who cast ballots in 2020. There are deceptively labeled petitions currently circulating to overturn the Governor’s veto of bills that would limit voting rights (Secure MI Vote) and another to provide state tax dollar vouchers for non-public education options (Let MI Kids Learn). For over 230 years our constitutional democracy has operated by the concept of majority rule with checks and balances to protect the minority. These petitions fly in the face of that historically proven concept. When presented with the opportunity, we would recommend that you simply Decline to Sign these petitions.

The 2022 election cycle will be interesting in Michigan. The recent redistricting process has moved many incumbent federal and state legislators into new districts. We will also be voting for the top three executive branch leadership positions. We urge you to reject broad labels, misrepresentations seen on social media, TV ads, or gossip over the back fence. Please take the time and effort to get engaged and vote for the candidates who will best represent you and your family’s needs and expectations. Use your vote carefully to save our democracy in 2022!

WOMEN'S RIGHTS RALLY HELD AT MANISTEE CITY HALL

The Manistee County Democrats held a rally for women's reproductive rights outside of Manistee City Hall on Saturday, October 2, 2021 with 80 people in attendance. Such rallies were held throughout the nation as a recently passed law in Texas has put a spotlight on reproductive rights. The law essentially bans abortions in the state after about six weeks after conception — before most women know they are pregnant.

“What’s happening in Texas right now, there’s no exception for rape and incest, and that is unacceptable,” Manistee County Democrats Vice Chair Rebecca Amidon said. “... I can understand putting some type of limits to a certain degree, but when you say no exceptions, then we can’t be OK with that.” Amidon said the rally was a sister event to the national Women’s March held in Washington D.C.

“We just felt we needed to represent here in Michigan because there is a court case that will be heard by the supreme court in a couple of months which could cause Roe v. Wade to fall,” she said. “If it does, there is a pre-Roe law on the Michigan books, so then Michigan women would possibly lose any access to abortion care. We just felt it was important to have our voices heard in case that were to happen.”

Shirley Madden, chairperson of the Blue Tigers, the community outreach organization of the Manistee County Democrats, told attendees an abortion ban would not stop abortions, it would only stop safe abortions. Madden shared the story of her college friend who became pregnant during her freshman year — before Roe v. Wade — and the terrible repercussions suffered by a woman who did not have a safe way to terminate the pregnancy.

“We’re not really taught proper sex education in public schools or by our parents — especially if they’re religious they might push abstinence only. So many women are ill-equipped to control their own reproductive health and when that happens they get pregnant unintentionally,” Amidon said. “Then they can’t go to school, can’t get an education, can’t get a career and then they’re trapped in a cycle of poverty. We need women to be empowered so they can take control of their own lives and have children when they’re ready.”

Madden told those in attendance that abortion bans fly in the face of the principals that built America.

“This country was founded on the freedom of choice,” she said. “That’s why it was founded, and we are going to make sure that we follow through with the freedom of choice for women.”
