## COMMENTS FROM THE CHAIR

Lately, I have become very concerned about the issue of firearm safety and more generally, the rule of law in our community, in our state, and in

our country. I was troubled a couple of weeks ago when I read an article in the News Advocate that concluded with the suggestion that it is perfectly acceptable for individual citizens to use firearms to oppose what they perceive as government overreach. Really? Does this mean that it is OK for me to judge the merits of any law passed by any level of government and use my gun to oppose its enforcement? I don't think so. I always thought that my personal responsibility as a citizen of this country was to obey the laws. I know that I am always free to oppose laws that I strongly disagree with by joining with other like-minded citizens to get them changed. I know that I can pursue legal remedies if I care to, or I can write to my representatives in government. I am also free to actively protest laws that I don't support. But I am not and should not be free to use violent means whenever I disagree with my government over an issue.

A few days later I learned that a group of 2nd amendment supporters were planning to ask our county commissioners to adopt a resolution making Manistee a 2nd amendment sanctuary county, meaning that our county would then refuse to obey any state or federal law that infringed upon our 2nd amendment right to bear arms. To my mind, this effort also seeks to circumvent the rule of law in our society. Many people came to the latest county commissioners meeting to speak in support of and against the adoption of this ill-conceived and dangerous resolution. Thankfully, the commissioners declined to act and Manistee did not join the list of counties that have already adopted it.

Finally, we have the spectacle of our President all but directing the US Attorney General William Barr, via twitter, to alter the sentencing recommendations for one of his longtime friends! While this is technically not against the law, it does certainly undermine the independence of the Justice Department and the public's respect for the law. Are we headed to a time when the law is whatever the president says it is? Isn't that the way it is in a dictatorship like Russia? Are we heading in that direction? I wonder!

I think we all need to pay very close attention to events like these and take every opportunity to speak out against the erosion of the rule of law in our society. We must not be afraid to speak up to friends and family about this and other serious issues. Our failure to do so may very well embolden others to continue along the dangerous path to anarchy. This year we have a chance to correct many of the dangerous trends we have recently witnessed. We need to pay very close attention to what is happening during this election year and take our responsibility to vote seriously. ## Law limiting Michigan ballot drives unconstitutional, court rules

LANSING – A state appeals court on Monday struck down major portions of a law that would have made it more difficult for citizens to launch ballot initiatives in Michigan.

The law, passed by Republicans during the 2018 lame-duck session of the Legislature, imposed a 15 percent limit on the number of signatures ballot petitioners could gather from any one of Michigan's 14 congressional districts. It also required petitioners to sign affidavits indicating whether they're paid or volunteer and display that designation on petitions.

The court struck down all three requirements, ruling they impose unconstitutional burdens on those signing and circulating ballot initiatives. The ruling largely affirmed a lower court's decision from September.

"Setting a 15 percent geographic limitation serves to take power out of the hands of the people," wrote Judge Deborah Servitto in the opinion joined by Michael Gadola. "This places the cart before the horse and unduly burdens the initiative and petition process."

The requirement that circulators sign an affidavit indicating whether they're paid or volunteer impose a "significant burden" on voters' First Amendment right to political speech, Servitto wrote, adding "no real governmental interest has been asserted" about the necessity of the rule.

"The circulators' right to be free of potential 'heat of the moment' harassment and to protect their privacy regarding their status as either a paid circulator or a volunteer, as well as the sponsors' right to have circulators engage in discourse with voters, outweigh the state's generally stated interests in transparency and accountability," Servitto wrote.

"The Legislature has simply not demonstrated that [the law,] PA 608's check-box requirement is necessary to serve its vaguely-asserted interests."

Other elements of the law, such as a requirement that the Board of State Canvassers decide whether a ballot initiative has met its signature requirements at least 100 days before the election, can remain, the court said.

Attorney General Dana Nessel last year determined most elements of the law were unconstitutional, prompting the Republican-led Legislature to sue Secretary of State Jocelyn Benson, who like Nessel is a Democrat. The League of Women voters also challenged the law's constitutionality and the two cases were consolidated.

The state House and Senate could appeal to the state Supreme Court. Aides for Senate Majority Leader Mike Shirkey and Speaker of the House Lee Chatfield told Bridge via email they are “reviewing the ruling and considering options.”

Legislative leaders have maintained that the law is constitutional and should be implemented.

Secretary of State spokesman Jake Rollow said the office will review the ruling with legal counsel “before determining any next steps.”

Rep. James Lower, R-Greenville, sponsored the bill. At the time, he argued it would require petitioners to gather support from rural and suburban areas in addition to Michigan’s urban centers and to bring more transparency to the ballot initiative process.

## DEMOCRATS' PATH TO WIN THE SENATE BEGINS WITH RE-ELECTING GARY PETERS

The bill increased coordination between the Pentagon and states on PFAS remediation efforts. PFAS has contaminated drinking water in several areas of Michigan and poses a public health risk.
- **Lowering Prescription Drug Costs:** After meeting with Michiganders across the state, Gary led the way to lower prescription drug costs and hold drug companies accountable. Gary passed into law bipartisan legislation to lower insulin drug costs by speeding up approval of generic insulin medications. Further, Gary passed into law bills to combat monopolies by drug makers who have sought to reduce competition from cheaper, generic drugs.

Washington Republicans have taken notice of Gary's success as an independently minded fighter for Michiganders and have already spent more than \$1 million against him. Gary needs your support to continue his record of putting hard-working families first. Over 86% of Gary's donors have made a contribution of \$50 or less.
